

## Licensing Agreement

This agreement is entered into between the Mental Health Risk Retention Group, Inc. (hereafter MHRRG) PO Box 134, Roseland, NJ 07068 and any person or entity viewing, downloading, linking to, or using (hereafter, collectively, User) the Videos (hereafter Videos) and/or Documents located on the website [suicideprevention.mhrrg.com](http://suicideprevention.mhrrg.com) (hereafter Website).

### Introduction

MHRRG is a risk retention group which insures behavioral healthcare organizations. It engaged Dr. Thomas Joiner, a psychologist with expertise in the field of suicide risk, to develop the Videos on the Website and he has also provided the other Documents on the Website. ### Definitions
